# RAMANUJAN COLLEGE

Ramanujan College, a constituent College of the University of Delhi was established in 1958 as an evening college. The College has been accredited Grade "A++" by the National Assessment and Accreditation Council (NAAC) in its Second Cycle.

At present, Ramanujan College offers sixteen undergraduate programmes in different disciplines. In 2018, the College conducted a Course on Human Rights, Environment and Ethics through its National Resource Centre (NRC), under the Annual Refresher Programme in Teaching (ARPIT) scheme of MoE. Teaching Learning Centre (TLC) is mandated by the Ministry of Education (MoE) to organise Faculty Development Programmes (FDPs), Faculty Orientation and Induction Programmes (FIPs), discipline specific and interdisciplinary refresher courses, conferences, workshops, through offline and online modes. These programmes are based on indepth subject knowledge, quantitative and qualitative research methodologies, and on an interdisciplinary approach as is envisaged in the National Education Policy (NEP), 2020.

The TLC, Ramanujan College has been set up with the aim of "Reaching the Unreached" teachers in terms of regional diversity and geographically remote areas of the country. It has successfully conducted more than hundred learner-centric programmes since October 2017 and trained over one lakh teachers across the country in various discipline specific and interdisciplinary programmes.

## **CONCEPT NOTE**

Kautilya, also known as Chanakya or Vishnugupta, was the Indian political philosopher and statesman, who helped Chandragupta Maurya to establish the first unified state in Indian history in the fourth century B.C. Kautilya's Arthashastra, the oldest treatise and exhaustive compilation on statecraft, and on the issues of the political economy, was discovered in the early part of the 20th century. A written guide for "those who govern", it is one of the greatest Indian treatises on the art of governance and administration in contemporary times. It extensively discusses war, diplomacy, peace, intelligence and security. Kautilya underlined the role of knowledge management to economic prosperity.

The Arthshastra is the most comprehensive treatise on Statecraft, virtually dealing with every aspect of governance and skillful management of the affairs of the State. Kautilya's Saptang Theory, seven constituent elements of the State, even though propounded in the context of a monarchical state, holds relevance even today in the context of republican and democratic governments. Kautilya is not only pragmatic in his approach but treads rather skilfully the fine balance of religion, ethics and politics.

Kautilya's ideas and concepts have astonishingly found relevance not only in the contemporary political economy and economics of governance but also in the practice of management. Contemporary management theories have drawn many concepts from Kautilya's writings (Arthashastra, Chanakya Niti, Nitishastra). His writings have influenced several branches of management; e.g. strategic human management, financial management, resource and management. Based on understating and interpretations of Kautilya's writings, several authors in current times have drawn valuable insights for corporate social responsibility, value based management, land management, organizational system, recruitment system for top positions, feedback system, etc.

This Programme is an endeavour to build a holistic understanding of the text "Kautilya Arthashastra" with an inter-disciplinary approach. It would raise the following topics for discussion in the context of the ancient text.
